Attention all Law enforcement and local service providers.

Red River Delta Law Enforcement Planning Council, Inc. is the organization responsible for allocating federal funding through the Office of Juvenile Justice and Delinquency Prevention for the Title II Juvenile Justice and Delinquency Prevention (JJDP) formula grant program. The federal amount available to the Red River Delta District is as follows:

Juvenile Justice and Delinquency Prevention (JJDP), FY 2022 – \$23,526

Red River Delta LEPC, Inc. is required to allocate these funds to one program. Please give some immediate consideration to types of projects you are interested in continuing or developing.

To streamline the application process, please follow the instructions below to submit an allocation request for FY 2022 JJDP funds.

- 1) Visit our website, www.rrdnw.com.
- 2) Click either the RRD logo, OR, click the orange RRD district in the map on the right.
- 3) Under the "Funding" tab, click the "Available Funds" button. You may also access the page by typing the following link in the web browser: <https://rrdnw.com/rrd/available-funds>. Choose the section titled, "FY 2022 JJDP".
- 4) Complete the appropriate request documents for each project: *JJDP Notice of Intent*, *JJDP Applicant Information Form*, and *Conflict of Interest Forms* (for the Authorized Official, Project Director, Financial Officer, the person responsible for grants, and any person listed on the grant, if different).
- 5) After completing and having the authorized official sign the request documents in blue ink, upload the documents on our website using the submission form at the following link:
<https://rrdnw.com/rrd/allocation-request> **no later than Wednesday, February 28, 2024**. Any request submitted after this date will not be on the agenda for the Project Priority Committee Meeting.

The Red River Delta Project Priority Committee will be meeting on **Thursday, March 14, 2024 at 9:00 am** at the RRD Office, 615 Main St., Pineville, LA 71360 to hear proposals. A representative from your agency is required to attend and must present a brief explanation of your proposal to be eligible for funding. No funds will be allocated to an agency without a representative present.
